

FMCA International Convention and RV EXPO in Gillette

This is a heads-up concerning registration for the FMCA International Convention and RV EXPO in Gillette, WY to be held **July 18-21, 2018**. There are many types of parking arrangements available for the event such as sewer or no sewer; 50-Amp, 30-Amp, or no electricity; and water or no water. To be parked together as a group, there are a couple of things that need to take place:

1. We must arrive together as a group at our assigned group time
2. We must be registered in a common area such as 50-Amp with water and sewer.

Several members who are in the Phoenix area for the winter have already noted these requirements and have registered for that particular designation (50-Amps with water and sewer) - even several that only need 30 amps. While there are less expensive parking options (such as no sewer, no water, no electricity, or 30-Amp service or any combination of those parameters), many of the Ramblin NoDaks have already registered in the 50-Amp, water, and sewer area so that we can be together as a group and enjoy common social activities. Saving money by going without sewer hook-ups might be as expensive if you find you find the need to have a truck come by and pump the holding tanks later on during your stay. Registration forms are in all of the late issues of the FMCA Family Motor Coaching monthly magazine. I recommend registering as early as possible to get your desired parking area.

Also, regarding the pre-rally at Spearfish: the Elkhorn Ridge Campground Resort is holding a block of sites for the Ramblin NoDaks pre-rally for **July 13-15, 2018** (You can reserve more or fewer days) until **5/10/18** at a rate of \$63.77 per night. This is a bit spendy for three reason:

1. Location - most Black Hills campgrounds are expensive during the warm months
2. The campground is an absolute first class facility
3. All campgrounds on routes close to the Gillette Rally are fully booked before/after that rally

There will be plenty of time available to tour the Black Hills area. (That never grows old.)

The address for Elkhart Ridge Camping Resort is 20189 US Hwy 85S, Spearfish, SD (Exit 17 off I-90).

The Ramblin NoDaks will caravan from the Elkhorn Ridge Camping Resort to the Gillette Rally on the morning of **Monday July 16, 2018**. The pace will be safe and comfortable.

Following the Gillette rally, a rolling rally might be presented by the Northern Lights Chapter that would leave on Sunday following completion of the Gillette Rally and would pass through various points of interest in Wyoming, Montana, and Canada. The status of this event has not been finalized.

Pre-Rally and Gillette Convention

Time is getting closer for registrations and reservations. So far it looks like several are planning to attend. If you have any questions, please contact Gene Grimm or Pam Meier.

PRE-RALLY: We have a block of spots reserved at the Elkhorn Ridge RV Resort in Spearfish, SD. The campsite dates are July 13, 14, and 15, 2018. You must make your own reservation. You can reserve any or all of the dates. The phone number to reserve at the resort is: 877-722-1800. Please tell them that you are with the Ramblin' NoDaks. This block of spots will only be held until May 10, 2018, at this time they will be released. The sites are 50-amp full hook-up pull throughs and the cost is \$63.77 per night.

CONVENTION: Registration is now taking place for the convention in Gillette. If you register before May 23, 2018, you will receive the "early bird" discount. Parking together can be a problem if we choose different parking arrangements. It has been the general consensus that most everyone is parking in the deluxe 50-amp. This is full hook-up with 50-amp (water, sewer, electricity). You may choose a different parking arrangement if you would like but if you are wanting to park with the group, this is the one you would want to choose. As a group, we are volunteering for the donuts and coffee. There is a place to mark that on your registration. You will also want to mark that you are coming in with the Ramblin' NoDaks caravan.
